- 1. A map and pitch number will be sent to you 4 weeks before the event. You must trade within the area you have been allocated.
- 2. Stall holders must set up between 8am 10am.
- 3. Please unload your equipment / merchandise and park your vehicle in the allocated parking area, before setting up your stall.
- 4. A Free Parking Permit will be sent to you before the event.
- 5. Hot food cannot be sold on a Trade Stall, only by approved catering concessions authorised by the event organiser.
- 6. Cakes, sweets etc, can be sold from a Trade Stall, copies of the relevant hygiene / food handling certificates should be attached to your booking form.
- 7. Trade Stalls must only sell the merchandise listed on the booking form.
- 8. Generators can be used, please include this on your booking form.
- 9. No open fires / barbeques are permitted.
- 10. All Trade Stall Holders must have Public Liability Insurance.
- 11. Trade Stall holder's vehicles cannot only be brought on site when the show finishes at 3.00pm.
- 12. All rubbish must be removed from the site.
